DANGER LURKS IN CONFINED SPACES!



In spite of years of awareness and warnings, mariners and shipyard workers are still encountering toxic confined spaces in the course of their job responsibilities. The Coast Guard has recently warned of these dangers in spite of the known hazard. Tankers and fuel barges are not the only vessels where this danger can be encountered. Even aboard dry cargo ships any confined space that has not been properly aired or ventilated can pose a deadly risk. Be sure that all safety steps have been taken before you are asked to enter such a space. Being provided the

necessary SCBA (self contained breathing apparatus) is also imperative if there is any question as to the safety of the area.

OUESTION FROM THE BRIDGE



I was recently aboard a dry cargo ship and was asked to go down into a space that had only been ventilated by opening the access hatch. I refused unless I was accompanied with another crew member. Eventually, they reluctantly agreed and sent another sailor with me. We did not encounter any real problems but it

was poorly lit and had very stale air. Should I have refused

altogether without some type of air pack? Linden B. Norfolk, VA

Answer: It is always safer to have someone with you when you don't know what you are going to encounter. However, a breathing apparatus would have been safer. Next time, ask for them as most all ships are required to carry them. Keep in mind that more than 50% of the workers in confined spaces that die from toxic fumes are those attempting to rescue another coworker.
